RISKS

RULES

My child and I understand that Vancouver College's school rules apply during this event. I agree that I am legally responsible for my child's behaviour, including any loss, injury or damage caused by my child's failure to abide by the school rules.

RELEASE AND REIMBURSEMENT

In return for Vancouver College Limited (referred to in this Parent Consent and Assumption of Risk Form as "**Vancouver College**") allowing my child to participate in this event, I agree to release:

- (a) Vancouver College (2002) Trust, Vancouver College and each of their directors, trustees, officers, employees, agents, and volunteers;
- (b) the Ministry of Education;
- (c) the owners and/or operators of the facilities where this event is taking place and each of their respective directors, officers, employees, agents and volunteers,

(collectively, the "**Released Persons**") of all responsibility for any injury, loss or damage which my child may sustain as a result of participating in this event, unless such injury, loss or damage is caused by the negligence of any of the Released Persons while acting within the scope of their duties. I understand that I am agreeing not to sue any of the Released Persons for any injury, loss or damage suffered by my child while on this event except for injury, loss or damage caused by the negligence of any of the Released Persons while acting within the scope of their duties.

I agree to reimburse any of the Released Persons for all liability, costs and expenses which they may incur as a result of any injury, loss or damage which my child may sustain while participating in this event, unless such liability, costs or expenses are incurred as a result of the negligence of any of the Released Persons while acting within the scope of their duties.
